Climate/Species Information: to inform

Mr Sterling requested the members to consider the following:

"I want parish councils to declare a climate and wildlife (or biodiversity) emergency. The UK government, and those of Scotland and Wales, plus dozens of towns and cities across the UK have already declared "a climate emergency". But like the Irish government which recognises the sheer gravity of the crisis facing us, it is vital to understand that both climate turmoil and species extinction are two aspects of the same terrible crisis. Why?

Well, take the climate: the UN has made clear we have a limited window of opportunity before 2030 to limit climate breakdown - to under 1.5 degrees after which runaway, uncontrollable, feedback will occur. It's already started but with radical logistical structural changes in the way

society is organised we just still have time. Many local councils say they want to be carbonneutral by 2030 - a much more ambitious target than the UK government's, which is to reduce carbon emissions by 80% (compared to 1990 levels) by 2050.

But the point is anyway, climate turmoil is indeed just part of an even more comprehensive existential threat before us: it's not just carbon or other gases like nitrous oxide (300 times more potent as a greenhouse gas than CO 2 which accumulates over 150 years and is higher today than at any other time during the last 800,000 years - but it's the wholesale decimation and extinction of the ecological structure of the Earth, the disappearance of the number and proliferation of species and their habitats, and the falling apart of the integration and interdependence of their life cycles. Wildlife is the operating system of life on Earth, and upon which we absolutely and completely depend.

To quote the UN's biodiversity chief Cristiana Paşca Palmer, in a recent report, who says "We're losing species at a rate never seen before. This is eroding the systems that sustain life on earth, including human life. The greater threat to humanity comes from the conversion of wild habitats to farmland, the degradation of soil, overconsumption in wealthy nations and the pollution of rivers by industrial effluent, agrichemicals and plastic.

Achim Steiner, administrator of the UN Development Programme said, "Biodiversity and the ecosystem services it supports are not only the foundation for our life on Earth, but critical to the livelihoods and well-being of people everywhere.

And Francisco Sánchez-Bayo, at the University of Sydney, Australia said, "If insect species losses cannot be halted, this will have catastrophic consequences for both the planet's ecosystems and for the survival of mankind."

The impact of ever-expanding transport, road traffic and urbanisation is at the forefront of all this and the impact on human health. Studies show how just the continual noise sets off the body's acute stress response, which raises blood pressure and heart rate, potentially mobilising a state of hyperarousal. It is this response that can lead to cardiovascular disease and other health issues leading to 6.500 deaths per year in the UK. The pollution, the isolation and impersonality of it also has a direct impact on our health - studies show that living near heavy traffic increases dementia risky by more than 10%, and even the experience on (what's left of it anyway) - as though it's not finite and is there for the purpose of being processed into monetary, economic and material gain.of congestion increases cardio vascular disease including heart attacks, strokes and high blood pressure.

All of which calls for a complete reversal of our mindset to the positives of localised, community-based economies and life styles and to seeing nature as absolutely, critically valuable, *in and for itself* - ie in its own terms - for the sake the cohesion, health and survival of this planet, and therefore of ourselves - *and away* from what we habitually see as a series of yet unused and unspent, so-called 'natural assets' i.e. land (including its vegetation - including trees, as in forests), minerals, animals , water, the seas, air and so

I know that this would come over as a somewhat more massive picture than what a parish council would think they are dealing with.

But the point is this: the outcomes of economic globalisation, in terms of environmental and human impact and degradation, is by definition experienced *locally - all* round the world. Whilst dealing with these outcomes locally may feel like spitting into the wind because the problems and their solutions are seen as down to forces beyond our control - such as governments and global corporations etc. - is it not also secretly welcomed in that it lets us off the hook to not bother to do anything - a very convenient rationale.

Plus, we hope that techno fixes, like electric cars, will enable us to continue as we are, but just with different technology. But planes? Lorries? Ships? - all in booming numbers. And electric vehicles pollute anyway. Indeed, they might pollute much more than petrol or diesel-powered cars, according to new Norwegian research. (The Norwegian University of Science and Technology) and electric car factories also emit more toxic waste than conventional car factories, according to their report in the Journal of Industrial Ecology.

But in any case, more traffic of any kind creates the impetus for ever faster building of ever bigger and ecologically disastrous roads, which in turn automatically create the dynamic for ever-larger rampant development, rolling over, at an ever-increasing pace, areas that previously would have been out of bounds ecologically and for the health and people's sanity. (Studies clearly show that we too simply need to be amongst prolific greenery and open spaces for our mental health).

So, most of this development is not due to the pressure of housing need - a much-used, purposefully misleading, term (as is 'affordable housing' - 80% of massively high market rates way beyond those in real need). If it were about need, it would be about social housing - until recently, being sold off - and housing association part-ownership schemes - which the government has also tried to put on the market too. Instead of which swathes of areas of numerous executive housing proliferate, entirely motivated by large profit-making, by both corporate developers and land-owners (and, it has to be noted, for the housing bonuses for cash-strapped - significantly, in this context - councils). Everyone is on a roll of financial self-interest so are blind to the wider housing, ecological and human costs.

Every such development generates urbanisation, the de-personalisation of life, with increasing crime outcomes - and yet more and more *traffic*. More traffic means more roads and further commercial development. And so more traffic. And so more roads. And more commercial development. And more pricey housing. And so more traffic. And so on. And on. And on. The relief - of relief roads - is simply temporary - whilst nature and green open space is seen as sacrificial to this behemoth.

<u>But it just has to stop</u>: it has no future - not least because the supply of the resource - principally land space and water - is not endless. They will run out way before the pressures

to build will do, and while it has no future, nor will we - the natural ecology will be decimated and, on its knees, along with us.

Why call for action at parish level? Because, I repeat, the impact, all round the world, *is local.* That's where the dramatic effects happen. And if parish councils were to wake up to their responsibilities to their areas in these terms - and make a public stand - it would have a growing impact on those with greater and wider powers to enable the necessary changes in which the environment - the ecological system - and human health become *absolute* priorities - built into planning law." (Andrew sterling 03/07)
